- Discussion about holding other games and activities during picnic. TH requested that people send her ideas.
- Raffle
 - Cash prize will be offered. Percentage of ticket sales.
 - Suggested price of \$1 per ticket
 - Must be present to win.
 - Will hold drawing at the beginning of annual meeting.
 - Action Item: SS to bring a roll of tickets for raffle to the Events Committee meeting.
- Email invitations will go out before the end of the month to the people in database
 - Action Item: JP will send TH and JS the address so she can enter the names from Tech Show.
- Action Item: TH to do agenda, task list, and needs list of the Events Committee meeting in two weeks.
- Action Item: TH to get email to retired teachers inviting them to picnic
- Action Item: DB to work on articles for the picnic newsletter. Will only be 1-page front and back since the tri-fold handout will cover much of what usually goes in the newsletter.

- BOD and Officer openings

 - There is a strong bond with the people currently in the google group.
 - There is a sub-committee of the LTDC to look into Charter Schools that includes DS, TH, DB, CH, Bill Diss (Benson CTE teacher) and Christie Plinski (former school principal).
 - This is currently a research group to discover if it would be possible to turn Benson into a Charter school and what it would take.
 - This would be a last resort effort to keep Benson 4-years.
