Met with Board Member Rosen and Athletic Director Haskins. It was an airing of our disagreements regarding the enrollment cap affect on the viability of Benson Athletics. We debated several points of the Plan B Consultancy draft report. Rosen committed that the Plan B report would be used as an opinion and not a recommendation. We have discussed the concepts of feeder systems and enrollment improvement for student athletes.

Jeanette DeCastro, '97 coming back around to involving herself with the school. Jeanette recounted her experience for ADA/accessibility based on her own experiences.
