BUSINESS

- Guest introductions:
 - o DM:
 - No rain at graduation, which went well.
 - Packers at at the school, getting everything ready to move.
 - 4 CTE programs are in carts ready to go. Kids leave this Friday, staff next Tuesday. By that time much will be ready to go.
 - Move out of building mid-July. Dan is in the building M-Th until 3PM usually.
 - Oct 18th 10-10:40AM is the first Pep Assembly, homecoming week.
 - There are 2 tour groups that day architects/builders group that primarily build educational institutions.
 Annual conference in Portland.
 - The first women at Benson Tech will be honored.
 - Administraters are back on August 5th.
 - Opening ceremonies Sept 14th.

- Alumni Room JP:
 - There is a small room off the library that is the alumni room at Marshall, went through items there with RE.
 - Now waiting to be let in to the building in August, then there will be time spent putting everything together.
- Site Council KC:
 - End of year review
 - DB was busy, so we'll connect with Kate Leonnard after 15th of June to discuss relaunching an aviation program.
 - o RK: Cost might be around \$5K
 - Need to discuss partnerships, how to answer PPS concerns, etc.
 Dual credit through PCC/Clackamas, etc.

- Other discussion around connecting with CTE faculty for health of program – one each month? They can come to us with needs, etc.
- Scholarship Committee RK:
 - o Gave out \$9K. Looked for those with financial need.
 - RK reaches out to the four seniors that received scholarships.
 Heard back from 2 so far.
 - This week RK will reach out to 2023, 2022 winners as well.
 - Hoping to get enough information to have an article in the September newsletter.
- Boosters JS:
 - New treasurer. Great group of 5 moms doing a lot for the administration.
 - Teacher appreciation week was great.
 - Social media is going well.
 - Some incoming parents are interested.
 - Thanks to JS for helping to keep the org alive.
- Digitizing Tech Pep RE:
 - o 1921-22 is now digitized.
 - Prices raised from 1.50 to 1.65 per page, but that will be good for the life of the project.
 - 22-23 is in their hands. The size increased from 5-7 columns, and the larger ones have had the edges bent, and are fragile.
- Discussed next meetings (see below) and determined we will continue hybrid meetings, in-person is preferred.
- Mr. Wilson put in orders for Astro gear, bring your CC. BT suggested that there may be school printable gear at the Grand Opening.
- Promoting Benson Tech alumni owned businesses TS:
 - Alumn contacted the association, she has a cigar company. This
 made us think about what our role is and whether we should
 promote alumni owned businesses.
 - Kenton station is another one, of course. Jay's Bike Gallery stores (sold now).
 - Website section with hyperlinks to each business? Great way of supporting other alums, job opportunities, etc.
 - Talked about an email blast/website section soliciting alumn's info about their businesses, purpose etc.
- BT: talked about Benson frying pan:
 - The 1974 Benson frying pan is off the roof of the Elderberry Inn restaurant for roof repairs.
 - The waiter said there will be a Grand reopening after the remodel work is done in August.
 - Said there were going to cook some food in it before putting it back up. Pan is aluminum with paint or epoxy on it.
 - Not sure how well that is going to work. Yuck.



- JP: Would we want stuff commemorating the re-opening? Sept 2024?
 - o Sticker? Mug? Patches? Plaque?
 - o Posters? Some site where they could order different things.
 - o DS gave his permission to use his drawing on the yearbook cover.
 - o RJ will talk to Bassetti about drawings.
 - We will communicate over the summer.
